Development Study of Hoffman's Corner Area: Results Begin to Emerge

The City Council extended the temporary moratorium on the issuance of building permits for development in part of Gem Lake's Business District, to June 30, as initial results of a land use study begin to come in.

The original moratorium temporarily suspend development for four months, starting last December, to allow time for a professional city planning firm to study land use dynamics, comparable properties, and other subjects that would help make Gem Lake a more attractive option for developers.

Marc Putman of Putman Planning and Design was hired to conduct the study, and is focusing on the area east of Highway 61 and north and south of County Road E. (Continued page 2)



County Commissioner Huffington Attends Meeting

Ramsey County Commissioner Blake Huffman attended the Gem Lake City Council meeting on March 18 in order to bring citizens up to date on county initiatives.

Huffman gave a presentation on his five major priorities for the year ahead. These five areas included:

- Maintaining public safety
- Taking care of those in need
- Supporting private sector business growth
- Controlling spending, and
- Maintaining infrastructure

Regarding public safety initiatives, Huffman talked about recent work within the Sherriff's Office to reorganize departments, establish industry leading training standards and rebuild relationships in the community. Development Study Results—Moratorium Extended to June 30

The overall goal of the study is to enhance Gem Lake's ability to be more supportive of, and attractive to, investment, development, building and tenant-owner businesses.

Intial data put together by Putman was discussed at the City Council workshop on April 14 at Heritage Hall. His research included current local and area competitive land value information, traffic volumes for the area, and demographic information for people living within one, five and fifteen miles of Gem Lake's business district. One of the goals is to eventually present all relevant data in a "realtor-developer-broker friendly" format.

Although the process has just started, there were some intial conclusions discussed at the workshop.

They include:

- There are multiple areas in the vicinity of the business district that have impressive traffic volumes each day.
- There are several underserved consumer needs in the area that could possible be served by businesses in the Hoffman's Corner area.
- The median home prices in the vicinity range around the \$250-275K mark
- The population is aging and may be looking for a range of housing, lifestyle options in the coming decade

The end result of all these efforts will be to find ways to make the Gem Lake business area more competitively attractive, when compared to other sites and cities, competing for a much reduced level of commercial development.

An important next step is to collect and analyze data obtained through a survey of residents and business owners within the city, which is now underway.

County Commissioner Lays Out Priorities

(Continued from page 1) stopping sex trafficking and establishing veteran's court.

Taking care of those in need is a huge priority for the county. Huffman reported that nearly \$150,000 was provided last year to the White Bear Lake Area Emergency Food Shelf for remodeling and expansion purposes. The improvements allow the food shelf to better serve their growing client base.

A thriving business community is key to a healthy tax base, according to the commissioner. Efforts to redevelop the Twin Cities Army Ammunition Plant (TCAAP) are a great example of the county's focus on private sector business growth. Preliminary master plans call for about 170 acres of the site to be zoned commercial, creating about 4,000 quality jobs. The finished plan will also include a mix of housing options, as well as commercial and retail portions.

A fourth priority is to control spending on the county level. The key to this is to address the drivers of poverty, a leading expense in the county's annual budget.

At this time of year, maintaining infrastructure is always on everyone's minds and is one of Huffman's primary priorities. The county has a special hotline set up for reporting pot holes. That number is 651-266-7100. The past winter was especially tough on county roads and there are one or two pot holes that need fixing...

Also, there are just a couple (hahahhah) road construction projects planned for the northern suburbs. Here is a partial list of roads that will get some TLC:

- Lexington Avenue, between I-694 and County Road F
- Buffalo Street, between Highway 61 and Portland Avenue
- Centerville Road, between County H2 and County J
- County Road J, between Centerville Road and Otter Lake Road
- Hamline Avenue, between County Road F and Highway 96

- Hodgson Road, between County I and County J, and
- LaBore Road, between 1-694 and County Road E.

April 30—Shoreline Restoration—6:30-8:30

Do you live on a lake, pond or stream and want to create a shoreline that is not only gorgeous but will help protect the health of that water? If so, join us for a fun class and learn about how we have altered our shorelines over the years and what you can do to protect your land from eroding away. Have a beautiful mix of flowers and grasses to look at from your yard and from your boat, AND help keep geese from hanging out in your yard. The cost for this session is \$10. Follow up this class by doing this assessment in your own yard and then bring the results to the next session, held May 20. The results will help with the design of your own raingarden. Ramsey County Traffic Safety Initiatives

The Ramsey County Sheriff's Department hosted a Distracted Driving enforcement detail on Friday, April 11 from 10:00 a.m. to 2:00 p.m.

Ten officers focused their attention on Highway 35W in both directions from Highway 36 to County Road J, while two officers rode a full size 77 passenger school bus calling out violations to squads in the area. A photo journalist from KARE11 also rode on the bus for a portion of the shift.
